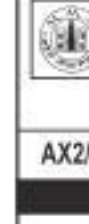

कॅनडामधील खलिस्तानी फुटीरतावादी हरदीपसिंग निज्जरच्या हत्येप्रकरणी तीन भारतीय नागरिकांना अटक करण्यात आली आहे. करण ब्रार (२२), कमलप्रीत सिंग (२२) आणि करणप्रीत सिंग (२८) अशी तिघांची नावे असून, त्यांचावर हत्या आणि हत्येचा कट रचल्याचा आरोप ठेवण्यात आला आहे. हत्येत सहभागी असलेल्या इतरांनाही लवकरच अटक केली जाईल, असे सांगण्यात आले. निज्जरच्या हत्येमध्ये भारत सरकारचा हात आहे का, याचा तपास करत असल्याचे रॉयल कॅनेडियन माउंटेड पोलिसांनी शुक्रवारी सांगितले. १८ जून २०२३ ब्रिटिश कोलंबियातील गुरुद्वाराबाहेर ४५ वर्षीय निज्जरची हत्या करण्यात



करण ब्रार, कमलप्रीत सिंग आणि करणप्रीत सिंग या तिघांना निज्जरच्या हत्येप्रकरणी अटक करण्यात आली.

रोहितच्या आत्महत्येच्या फेरतपासाचे आश्वासन

रोहित वेमुलाची आई राधिका वेमुला यांनी शनिवारी तेलंगणचे मुख्यमंत्री ए रेवंत रेड्डी यांची हैदराबादमध्ये भेट घेतली आणि आपल्या कुटुंबाला न्याय मिळावा अशी मागणी केली. त्यानंतर या प्रकरणी पुन्हा एकदा तपास केला जाईल असे आश्वासन मुख्यमंत्र्यांनी दिल्याची माहिती अधिकृत निवेदनात देण्यात आली. रोहितने २०१६ साली हैदराबाद विद्यापीठात शिकत असताना

आत्महत्या केली होती.

रोहितचा भाऊ राजा वेमुला याने सांगितले की, मुख्यमंत्र्यांनी या प्रकरणी पुढे निष्पक्ष आणि पारदर्शक पद्धतीने तपास करण्याचे आश्वासन दिले आहे. विद्यमान सरकारकडून आपल्याला न्याय मिळेल असा विश्वास त्याने व्यक्त केला. त्याने सांगितले की, "आम्ही पोलिसांनी दाखल केलेल्या 'क्लोजर रिपोर्ट'ला विरोध केला आहे. रोहितच्या जातीबद्दल स्पष्टीकरण देण्याचे सक्षम अधिकार आंध्र प्रदेशातील गुंटुर जिल्हा

अधिकाऱ्यांचे आहेत, पोलिसांचे नाहीत". पोलिसांनी स्थानिक न्यायालयात या प्रकरणी 'क्लोजर रिपोर्ट' दाखल केला आहे. रोहित दलित नव्हता आणि आपली खरी जात शोधली जाईल या भीतीने त्याने आत्महत्या केल्याचा दावा त्यामध्ये करण्यात आला आहे. रोहितची आई आणि इतरांनी 'क्लोजर रिपोर्ट'बद्दल शंका व्यक्त केल्यामुळे या प्रकरणी पुढील तपास केला जाईल असे तेलंगणचे पोलीस महासंचालक रवी गुप्ता यांनी आधीच जाहीर केले आहे.

‘विरोधकांनी माफी मागावी’

पुणे : रोहित वेमुला प्रकरणी काँग्रेससह विरोधी पक्षांनी देशाची व रोहितच्या कुटुंबाची दिशाभूल केली आहे. त्यामुळे विरोधी पक्षाने माफी मागावी, अशी मागणी भाजप नेत्या निर्मला सीतारामन यांनी येथे एका कार्यक्रमात बोलताना केली. यावेळी भाषण करताना निर्मला सीतारामन म्हणाल्या की, रोहित वेमुलाची आत्महत्या ही एक दुर्दैवी आणि आकस्मिक घटना होती. पण, विरोधकांनी जाणीवपूर्वक तो दलित असल्याचा अपप्रचार केला.
